# WAIKATO CATCHMENT ECOLOGICAL ENHANCEMENT CHARITABLE TRUST (INC) TRUSTEES' REPORT FOR THE PERIOD

#### 1 JULY 2006 TO 30 JUNE 2007

#### **Executive Summary**

This is the fourth annual report for the Waikato Catchment Ecological Enhancement Charitable Trust (Waikato Catchment Ecological Enhancement Trust). This has been a year of consolidation for the Trust both in its governance and its day to day management.

- The Trust received 15 applications for project funding in this year's grant round. Applications were of a
  high standard with project outcomes well focussed on the Trust's objectives. The Trust made grants to
  projects totalling \$231,015. Projects were scattered throughout the wider catchment, with large wetland
  projects in the Taupo and Rotorua areas being major grant recipients.
- The Trust furthered its intention to develop a proactive stance in allocating funds to foster those ecological resources that will have greatest impact on the sustainability of the Lake Taupo and Waikato River catchments in order to identify an area or areas for major strategic investment. In the next step along this pathway, the trust commissioned Alchemists Ltd to provide an analysis of potential gaps in existing ecological work programmes by key agencies in the Taupo Ecological District. Their report is expected in the second half of 2007.
- During the year the Trustees acted upon the advice of their investment consultant to purchase secured banking bonds and have now built a structured portfolio to generate income over the coming years.

#### 1. Background

The Waikato Catchment Ecological Enhancement Trust was formed with the execution of the Trust's Trust Deed on 13 June 2003. The Trust originated from the process of replacing the resource consents for the continued operation of the Waikato Hydro System. Mighty River Power, the owner and operator of the Waikato Hydro Scheme applied under the Resource Management Act (RMA) to replace the expiring resource consents that authorise the operation of the Hydro Scheme. Those organisations who are parties to this Trust worked together to develop an appropriate response in RMA terms to those applications. They recognised that there are a variety of ecological changes occurring in Lake Taupo, the Waikato River and hydro lake environments as a result of natural processes, other activities in the catchment and the operation of the Hydro Scheme.

The formation of this Trust was a significant part of the response of those organisations to developing a practical means of achieving:

- an acceptable response to the ongoing ecological changes occurring throughout the Lake Taupo and Waikato River catchments:
- an acceptable response to changes associated with the operation of the Waikato hydro system; and,
- wider ecological benefits in the Lake Taupo and Waikato River catchments.

#### 2. Purposes of the Trust

The Waikato Catchment Ecological Enhancement Trust was established for the following charitable purposes:

- To foster and enhance the sustainable management of the ecological resources in the Lake Taupo and Waikato River catchments;
- 2) To mitigate adverse effects of the operation of the Hydro Scheme on the ecological environments in the Lake Taupo and Waikato River catchments;
  - (i) identifying important habitats and/or species;
  - (ii) identifying risks and threats to those identified habitats and/or species;
  - (iii) identifying practical means to enhance important habitats and/or species;

- (iv) establishing an enduring and beneficial working partnership between Mighty River Power and the Trust; and
- 3) To receive monitoring reports on key ecological indicators in order to:

(a) identify ecological changes, their causes and implications (including determining the extent of Mighty River Power's influence on these changes);

(b) identify whether ecological changes are in accordance with Mighty River Power's predictions of ecological changes associated with its operations as set out in the Assessment of Environmental Effects (Taupo Waikato Resource Consents Application and Assessment of Environmental Effects, March 2001, Section 7.7, and its supporting documents).

# 3. Primary Activities of the Trust in 06/07

This has been a year in which Trustees have continued to consolidate the Trust activities as well as refining strategies and priorities to achieve its first two key objectives which are:

- to foster and enhance the sustainable management of the ecological resources in the Lake Taupo and Waikato River catchments; and,
- to mitigate adverse effects of the operation of the Hydro Scheme on the ecological environments in the Lake Taupo and Waikato River catchments;

Although the number of applications for funding received was markedly reduced from previous years (only 15 compared to 33 in each previous year) the standard was of high quality and applicants generally presented clear project management plans. While applicants' descriptions of the longer term benefits of their projects were more considered than in previous years, many did not identify how they would contribute to mitigation of effects of the hydro scheme. This deficiency was, in part, due to the nature and location of projects that are not relevant to the direct impacts of the hydro scheme; however our ongoing ability to find practical measures of mitigation needs further consideration. The need for robust systems of measurement to mark progress towards mitigation of adverse effects of the hydro scheme has previously been identified as an issue for the Trust and is an area that continues to challenge Trustees.

Previous reports have highlighted Trustees intention to identify key locations in which investment to foster ecological resources that will have greatest impact on the sustainability of the Lake Taupo and Waikato River catchments. This past year we have taken a significant step in this direction by establishing criteria for a Gaps Analysis then inviting interested parties to submit tenders undertaking such an analysis. The ecological districts of Taupo and Meremere are, in the view of Trustees, under the greatest immediate threat and have been awarded priority in examining this approach upon which to base investment decisions. Alchemists Ltd were the successful applicants and have been commissioned to undertake a study of the Taupo Ecological District. They will report back to the Trust later in 2007 with an analysis of work projects being undertaken by the various agencies in the district, and an indication of those areas that are most vulnerable and hence where Trust investment would be of most value. If a suitable project can be identified then the Trustees will consider making a significant contribution along with exploring opportunities to leverage from other projects/organisations working in that specific area. If this approach to identifying areas for investment proves successful then a further analysis in the Meremere Ecological District will be undertaken.

There was one change in the Trustees during the course of the year. Tim Densem, a Mighty River Power appointee, was replaced by Cherry Connew in March 2006.

Helen Broome continued throughout the year in the role of Secretary to the Trust, and Mike Hanaray of Accountants on London providing accounting services. Derek Brewster of ABN Amro Craigs continues to provide the Trustees with investment analysis and advice.

#### 4. Trust Milestones for 06/07

Key milestones for the Trust this year have been:

- Development of criteria for Gaps Analysis in the Meremere and Taupo Ecological Districts with letting of a tender for this activity.
- ii. Maintained and updated the Trust's website at <a href="www.wceet.org.nz">www.wceet.org.nz</a>. This included providing advice on project development and the application process.
- iii. Development of signage standards for use at project sites that will ensure that Trust contributions to projects is recognised.
- iv. News releases through local and regional media in relation to Trust activities and projects being supported.
- v. Launch of the Trust's fourth funding round on November 1<sup>st</sup> 2006, with applications closing 31 January 2007.
- vi. Receipt of 15 applications in response to the Trust's fourth funding round. These application were considered by a sub-committee of Trustees and recommendations made to the full Trust (15 March 2007)
- vii. Following consideration of those applications the Trust made grants to totalling \$231,015 to 15 projects distributed across the Trust's area. The grants made are detailed in the following table:

#### NOTES TO THE FINANCIAL STATEMENTS

#### FOR THE YEAR ENDED 30 JUNE 2007

#### 1 STATEMENT OF ACCOUNTING POLICIES

#### REPORTING ENTITY

The Waikato Catchment Ecological Enhancement Charitable Trust (Inc) was incorporated under the Charitable Trusts' Act 1957, on 22 August 2003. These financial statements have been prepared in accordance with the generally accepted accounting practice as defined by Financial Reporting Standards and Statements of Standard Accounting Practice as issued by the Institute of Chartered Accountants of New Zealand.

#### **MEASUREMENT BASIS**

The accounting principles recognised as appropriate for the measurement and reporting of financial performance and financial position have been applied on an historical cost basis.

#### **DIFFERENTIAL REPORTING**

These Financial Statements have been prepared by applying differential reporting exemptions. The Waikato Catchment Ecological Enhancement Charitable Trust (Inc) qualifies for these exemptions on the grounds that it is not publicly accountable and is not large.

#### 2 SPECIFIC ACCOUNTING POLICIES

The following specific accounting policies, which significantly affect the Trust's measurement of results and financial position, have been applied:

#### 1. Taxation

The Trust has been granted Charitable status for the purposes of the Revenue Acts, and in particular is exempt from income tax under Section CB4(1)(c) of the Income Tax Act 1994. Accordingly, no provision for taxation has been made on the net income derived during the period to 30 June 2007

#### 2. Goods and Services Tax

The Trust is registered for Goods and Services Tax purposes and the Financial Statements have been prepared on a GST exclusive basis

#### 3. Investments

Investments are recorded at market value as at balance date.

#### 4. Changes in Accounting Policy

There have been no changes in Accounting Policies. All policies have been applied on a basis consistent with those applied in previous years.

#### 3 COMMITMENTS

Outstanding Grants approved but not paid as at balance date have been accrued as Creditors. There are no other commitments at 30 June 2007

#### 4 CONTINGENT LIABILITIES

The Trust did not have any contingent liabilities at 30 June 2007 (2006 NIL)

## 5 RELATED PARTY TRANSACTIONS

Funding for operations to date has been received from Mighty River Power Limited (MRP) under the terms provided for in the Memorandum of Understanding (MoU) of 15 October 2002 between MRP and the Trust. As part of the MoU, MRP has agreed to provide administrative support including the payment of administrative and audit expenses.
